

CONSEQUENCES FOR VIOLATIONS OF SCHOOL ATTENDANCE LAWS

If a student continues to miss school, he or she will be required to attend a Truancy Diversion Team meeting with family, school personnel, community services, and local law enforcement. Failure to attend this meeting and/or failure to follow through with the Truancy Contract may result in a petition being filed in Juvenile Court.

CONTINUED TRUANCY MAY RESULT IN ANY OR ALL OF THE FOLLOWING CONSEQUENCES:

- School Detention
- Supervision by County Probation Officer or Social Worker
- Community Service or work crew hours.
- Participation in individual or family counseling, completion of a psychological or chemical health evaluation, or participation in group education programs
- Parent court ordered to attend school with student.
- Student fined up to \$100 or parent held liable for prosecution for student's truancy with a penalty of up to 90 days in county jail and/or up to \$1,000 fine.
- Driver's license suspension until age 18.
- Home detention (cannot leave home without parent except for work or school)
- Placement in shelter or correctional facility with parents responsible for costs according to ability to pay.

MISSION STATEMENT

The Koochiching County Attorney's Office, Community Services, Law Enforcement, School Districts, and Ninth Judicial District believe that regular school attendance is directly related to success in academic work while benefiting a student socially and establishing regular habits important to the future of a student. The purpose of this policy is to encourage regular school attendance and, if necessary, compulsory attendance. The goal of this policy is to outline the expectations of the Koochiching County Attorney's Office, Koochiching County Social Services, and the participating School Districts.

HOW THE TRUANCY PROCESS WORKS

The Koochiching County Truancy Policy is a program designed to prevent and intervene to improve school attendance.

The law requires that the school notify the County Attorney's Office when a student has 7 or more unexcused absences.

Upon receiving this notice, a Truancy Diversion Team will be assembled and the student and parent will be required to attend a Truancy Diversion Meeting. At the meeting, school staff and representatives from community social services and law enforcement will work with the student and parent to identify barriers to attendance and recommendations for overcoming these barriers. These recommendations will become part of a Truancy Contract that the student and parent will be asked to sign. At this meeting, team members will explain to the student and parent the legal requirements and consequences if the Truancy Contract is not followed.

DEFINITION OF TRUANT

A child is considered a "habitual truant" if he or she is under the age of 16 years and is absent from school without lawful excuse for seven school days or for one or more class periods on seven school days. Children ages 16 and 17 will be considered truant if they have not lawfully withdrawn from school with their parent's permission. Minn. Stat. 260C.007 Subd. 19

EXCUSED ABSENCES

A parent or guardian may seek an excused absence from the school for his or her child. A school has the right to accept or deny the request for an excused absence. Absences are calculated according to the individual district's attendance policy.

FOR AN ABSENCE TO BE EXCUSED, A PARENT MUST, AT MINIMUM, REPORT THE STUDENT ABSENT

ACCEPTABLE ABSENCES:

- Sickness (may be required to provide written verification from doctor or nurse)
- Death in Immediate Family
- Medical or Dental Appointment
- Court Appearances
- Religious Instruction or Holiday
- Physical or Family Emergency
- Official School Trip or Event
- Family Vacation w/ proper notice to school
- Driver's Education

INVALID EXCUSES (EXAMPLES)

- Tanning Sessions or Hair Appointments
- Babysitting
- Work at home
- Travel/Vacation without notice to school

RESPONSIBILITY OF SCHOOL

- Provide program/schedule that meets student's educational needs.
- Maintain accurate attendance records and document communication with student and family.
- Refer student to County Attorney's Office when Truancy Contract is not being followed.
- Inform parents and student of legal requirement of attendance and possible consequences if there is failure to meet those requirements.

RESPONSIBILITY OF PARENT

- Send your child to school.
- Inform the school when your child may need to miss school for an acceptable reason.
- Attend any Diversion Meeting with your child and follow the recommendations of the Truancy Contract
- Monitor your child's attendance.

RESPONSIBILITY OF STUDENT

- Attend school, every day, every class, and be on time.
- Complete required school work and ask for assistance when needed.
- Attend a Truancy Diversion meeting and follow the recommendations of the Truancy Contract
